**PLEASE NOTE:** During School Holidays (HPS) members may book for a maximum of 2 weeks only.

1. The member must phone the Air Force Fund from end November 2017 for results of their application form school holidays.
2. Tariffs are subject to change. Tariffs for the 2018 are available at the SAAF Fund office, on the intranet (DOD website) as well as internet.

3. **PAYMENT**  
20% of the total accommodation fee is payable within one week after the flat has been allocated to a member. (In case of timeshare 50%)  
The booking will be cancelled and the flat will be allocated to the next person if the deposit is not received within the prescribed period.
4. **CANCELLATION**  
Cancellation more than two months before holiday – deposit less 50% will be refunded.  
Cancellation less than two months before holiday – deposit less 80% will be refunded.  
(Refunding of the deposit is subject to the condition that the flat will be relet).
5. **BOOKINGS ARE NOT TRANSFERABLE**
6. **OFFICIAL APPLICATION FORM**  
Applications for reservations for all the school holidays may only be submitted on the official application form.
7. **HANDING IN DATE**  
The application forms for the school holidays must reach the Air Force Fund office from 02 to 31 October 2017. Only one application per member, if more the others will be destroyed. **NO LATE APPLICATIONS WILL BE ACCEPTED!!!**
8. **OCCUPATION**
  - a. Only beneficiaries of the SA Air Force Fund may utilize the accommodation.
  - b. No family members/friends of the beneficiaries may occupy the accommodation facilities unless the beneficiaries are also occupying the accommodation.
  - c. Beneficiaries, who book accommodation and allow a person or persons who are not members of the Air Force Fund to occupy such accommodation contrary to the abovementioned provisions will have their bookings cancelled immediately (even whilst in occupation) if it becomes evident that the booking was made on behalf of non-beneficiaries. No rent, which has been paid, will be refunded.
  - d. No pets allowed.
  - e. No smoking allowed in Fund accommodation (Units and timeshare).
  - f. Beneficiaries are to comply with the Body Corporate conduct rules.
9. **RESERVATION.** This is not a booking form but an application for a holiday reservation.
10. **IDENTIFICATION**  
Members must produce ID document and a confirmation of booking to the caretaker on arrival to ensure entry to the accommodation.
